about us.

Established in 2009, Chesapeake Housing Mission (CHM) is a nonprofit 501(c)(3) charitable Christian mission that offers critical home repair services to low-income families residing in Maryland's Dorchester, Somerset, Wicomico, and Worcester Counties. These services are provided entirely free of charge as part of our core focus on helping those in need.

We believe in the power of community and have successfully assisted hundreds of families through the generosity of donations and volunteer efforts. Our projects often involve the construction of wheelchair ramps, which are completed in a single day by dedicated volunteer teams. This work fills a critical need in our area and enables our clients to age in place safely and improve their overall quality of life.

services.

Many of our projects are performed by volunteer teams that have pledged to dedicate a day to help their neighbors.

We offer a wide variety of basic construction and home repair services that compliment the skill sets of our volunteers and operations staff.

Volunteer teams include businesses, schools, churches, government offices, and other organizations. Teams can consist of both adults and youth, and on-the-day training is provided for our volunteers.

The majority of our clients come to us through recommendations from local agency partners such as MAC, Somerset (SCCOA) and Worcester (WorCOA) Commissions on Aging, Maryland Access Point (MAP), and Delmarva Community Services (DCS). Every client is screened for financial eligibility.

We meet with our agency partners monthly to prioritize and ensure that the most urgent cases are serviced first. Depending on our current waitlist, it may take several months before we can address our clients' projects. However, we always let them know that we have not lost sight of their needs.
